Child protection is part of safeguarding and promoting the welfare of children Child Protection is defined as any activity that is undertaken to protect specific children who are suffering, or are likely to suffer, significant harm (physical, emotional, sexual, neglect, organised abuse)

Child Protection - Protecting a child from child abuse or neglect Abuse or neglect need not have taken place; it is sufficient for a risk assessment to have identified a likelihood or risk of significant harm from abuse or neglect Safeguarding - This is a much wider concept than
