### **EFFECTIVE INTERVIEW TECHNIQUES FOR HIRING INTERNAL ...**

Because candidates for entry-level internal audit positions may not have previous audit experience, a writing sample may identify skills in this area. A writing sample would identify well-organized, clear, and concise writing skills. An interviewer could assign a candidate to summarize auditees' responses to auditor questions.

### **THE SITUATIONAL INTERVIEW**

By questioning internal audit management in various types of companies through surveys, the many aspects of interviewing for their internal audit positions has suggested a more effective way to interview and evaluate candidates that combined older methods with a newer technique called situational interviewing.
